

Terms and Conditions
Marina Pier Glenelg – Autumn Competition

Key Terms:

Information on how to enter and win the prize form part of these conditions. By participating, entrants agree to these terms and conditions. Entries must comply with the conditions to be valid.

Eligible Entrants:

1. Entry is open to all permanent South Australian residents aged 18 years and over.
2. Employees (and their immediate families) of the Promoter or onsite venues, are not eligible to enter Marina Pier Glenelg competitions.
